District Judge Cathy Prewitt and Elissa Price, with Operation Unite came before council asking for an Ordinance to be approved banning synthetic marijuana, which is being sold as potpourri or incense, and synthetic cocaine, which is being sold as bath salts, plant food or jewelry cleaner. Judge Prewitt stated that the normal drug test used in the drug court doesn't screen for synthetic marijuana so a second test is needed, which costs about \$35 each and only screens for a portion of the substances, which can be classified as synthetic marijuana.

Elissa Price, with Operation Unite said that synthetic marijuana is about 500-700 times more potent than marijuana; the drug is causing problems, such as heart attacks in 18 year olds and permanent psychosis.

III.
